047/24 To hear any matters raised by attending Parishioners (10 minutes maximum):

Objections to the installation of floodlights on the Tennis Courts were raised as it was felt that they would affect neighbouring properties. The Clerk pointed out that a formal notification of a submitted Planning Application had not been received at this time. Cllr Patient assured those present that once an application had been received, the Parish Council would hold a meeting with parishioners to discuss the matter further.

An enquiry was made into the increase in the Precept. It was explained that the Precept had been increase by £3000 which was to cover the cost of employing a 'lollipop person' during drop-off and pick-up times at the school. Unfortunately the costs have increased and therefore further funding would be required. However, it is now possible for Parish Councils to purchase Speed Indicator Devices (SIDs). The increased amount will be allocated to Road Safety. Councillors are looking into additional sources of funding. The Parish Council is awaiting a response from ERYC about an appropriate placement of SIDs. Meanwhile, a Police presence will be requested near the school in an effort to increase road safety in the area. **AP**

- 068/23 i) Emergency Box a larger pump, sand bags and road signage have been purchased to aid flood defences in the village.
- 020/24 i) Drainage Yorkshire Water have responded to the Freedom of Information request which has been made, however, it is felt that the information supplied does not fully answer the questions raised. The Clerk will ask for clarity. YE

Cllr Lovatt reported that Yorkshire Water has cleared a soft blockage, though this was not the cause of the recent flooding. An engineer has stated that the main cause is that ERYC Highways have not cleared the gullies.

The Clerk will ask ERYC Highways for the gully clearing schedule. YE

A cctv survey of the drainage system to the outfall behind Herdborough House is required.

ERYC and Yorkshire Water will then be asked to meet with the Parish Council.

Cllr Flanagan will draft an email to request a cctv inspection. SF

Cllr Muress will be asked to check if the ditch behind Jervis Court has been cleared. It is felt the poor land management by the Crown Estate is exacerbating the situation.
